STUDY ABROAD BELIZE 2015 is the continuation of a successful launch of "International Classroom Initiative" developed by Attorney/Associate Professor Deborah Wagnon, Dept. of Recording Industry/College of Mass Communication. It is based within Belize, an English (and Spanish) language democracy that serves as a safe and workable portal to the six remaining territories of Central America.

STUDY ABROAD BELIZE as an academic Summer Semester 3-credit program at the main campus of the University of Belize within the capital city of Belmopan, Belize, a relatively new city approximately 40 miles inland from the urban center, Belize City. The "International Classroom" is a focused inquiry into the developing entertainment and intellectual property-related industries of Central America, specifically looking at its current state and identifying opportunities for global growth and reciprocity with the fully-evolved U.S. intellectual property and entertainment industries. Subject matter will target the study of the global entertainment industry from an entrepreneurship perspective, essentially preparing students to handle the realities of business and law in foreign territories for all activities relating to entertainment, with focus on international film and recording industries but relevant to all areas of content creation and distribution. We also spend time in the recording studio, sail to barrier island/reefs and climb to the top of El Tikal!
